



Rules for using the social media of

We also wish to remind all users interacting with this community of the need to be polite and respectful in publications and comments, particularly when interacting with other members. Intellectual property and copyright laws must be observed.

Any comment or post from any user breaching the following rules will not be answered by ESTEVE's social profiles:

- If the post includes rude, defamatory, slanderous, offensive, abusive or discriminatory language or any kind of demeaning content (including images, video and links) about Esteve, participants of Esteve's social media or third parties.
- If the post is not related to the relevant social profile of Esteve.
- If the post contains confidential, sensitive, private, illegal or prohibited information. Also, if the post includes personal data such as email address or telephone number.
- If the post has commercial intent.
- If the post is detrimental to the community or is considered spam.
- If the post does not follow the Terms of Use of Twitter, Instagram or LinkedIn.

Because the pharmaceutical sector is highly regulated space, we remind you that no medicines or products from Esteve (or from the societies of its group) can be discussed in these profiles, except OTCs.
